GUIDELINES FOR STATE COMPETITIVE SCHOLARSHIP EXAMINATIONS AT THE STAGE OF CLASS V AND VIII IN MANIPUR

- **Title (1):** These Guidelines may be called the State Competitive Scholarship Examination for Class V and VIII Guidelines in Manipur.
- Purpose and Extent (2): (i) These Guidelines are adopted to conduct, regulate and supervise the State Competitive Scholarship Examination for the selected student of Class V and VIII in the Government / Government Aided / Recognised Schools of Manipur.
 - (ii) The State Competitive Scholarship Examination for Class V and VIII of the Government / Government Aided / Recognised Schools of Manipur will be conducted under these Rules by the Department of Education (Schools), Manipur with the assistance of a Committee in view of requirement from time to time.

Commencement (3):

- (i) These Guidelines shall come into force with immediate effect.
- (ii) From the date of enforcement of these Guidelines all previous Guidelines regulating scholarship examinations at the end of class V and VIII of the schools of Manipur will cease to exist and operate.
- **Definition (4):** Under this Guidelines, unless and otherwise specially mentioned,
 - (a) "Department" means Department of Education (Schools), Manipur.
 - (b) "Chairman" means the Chairman of the Examination Committee.
 - (c) "Secretary" means the Secretary of the Examination Committee.
 - (d) "Member" means the Competitive Scholarship Examination committee.
 - (e) "Rule" means the Competitive Scholarship Examination Rules.
 - (f) "Scholarship Examination" means the Examination conducted by the Department of Education (Schools), Manipur for selected students of class V and VIII in the schools of Manipur.
- 5. Eligibility:

 All students who have passed Class V and VIII in Government / Government Aided / Recognised Schools under the Department of Education (Schools), Manipur securing not less than 60% marks for General, 55% marks for OBC and 50% marks for SC/ST in aggregate in their annual promotion examination in the previous year will be eligible to appear in the State Competitive Scholarship Examination for Class V and VIII.
- **6. Syllabus:** The examination will follow the prescribed syllabus by the Board of Secondary Education Manipur for both Classes V and VIII.

9. Selection Procedure:

For award of scholarships, selection of students for the State Competitive Scholarship Examination for Class V and VIII will be as per Guidelines and terms and conditions of the scholarship approved by the Examination Committee from time to time.

10. Scholarship:

(i) The rate of scholarship for the State Competitive Scholarship Examination for Class V and VIII will be as per Rules and terms and conditions of the scholarship approved by the Examination Committee from time to time.

(ii) The duration of scholarship will be consecutive 3 (three) years for class V and 2 (two) years for class VIII.

11. Payment of Scholarship:

The scholarship amount shall be directed by credited into the account of the selected students by the Department of Education (S), Manipur through PFMS/DBT.

12. Disposal of Answer Scripts:

Answer Scripts of the examination will be preserved for a period of 6 (six) months after the declaration of the final result. Any complaint of the examination etc. shall be made within six months from the declaration of the final result. The complainant shall deposit a sum of Rs. 500/- (Rupees Five Hundred only) for reexamination of the subjects by challan to the Examination Committee.

The Head of Department, Directorate of Education (S), Manipur will issue Certificates of appreciation to all the selected students of the State Competitive Scholarship Examination for Class V and VIII.
