NOTIFICATION

In supersession of this Department's Notification No.Shiksha-ll-Ga(l l)-2/2002 dated 11th May,2011] the Governor,Himachal Pradesh is please to notify following guidelines for regulation/implementation of scholarship scheme of "Dr. Ambedkar Medhavi Chhatravriti Yojna" in the H.P. Education Department in the public interest,with immediate effect:

- 1. This Scholarship will be given to top 1000 meritorious students of Scheduled Caste category and top 1000 meritorious students of Other Backward Classes declared as such in the result of Matric Examenation conducted by the H.P. Board of School Education Dharamshala strictly on merit basis for +1 and +2 classes in a recognized institution with in or outside the state. The renewal in +2 class will be subject to satisfactory performance in 10+1 internal examination.
- 2. The Scholarship will also be given in case the eligible student takes admission in any professional/technical course after matric, in a recognized institution within or outside the state. However it will be limited for maximum of two successive years after matric. The renewal in 2nd year of the course will be subject to satisfactory performance in 1st year of the course.
- 3. Under this Scholarship Scheme an amount of Rs.10,000/-[Ten Thousand] only will be given to each eligible student per year for two successive years after matric.
- 4. The eligible Students must belong to Scheduled Caste and Other Backward Classes Category declared as such by the H.P. Government from time to time.
- 5. In case of any dispute, the Director, [Higher Education], H.P. will decide the matter /issues immediately. However, any person aggrieved with this decision may file an appeal before the Secretary [Education] to the Government of H.P. within 45 days of decision.
- 6. The eligible students will have to apply on the prescribed proforma along with Matric/Caste Certificates through their respective Heads of Institution. The Heads of Institution will then forward the dully filled up form to the Deputy Director of Education. The Deputy Director of Education will compile lists all eligible student of whole District concerned and will submit the same to the Director of Higher Education befor the date notified him in this regard.
- 7. In case of non availability/absence of Head of the Office in any institution /School,the eligible students may apply directly to the Deputy Director of Higher Education of the concerned District, H.P. who will process the case further on confirmation from the office concerned. However, no eligible student will be deprived of his/her Scholarship on account of delay in submission or otherwise. It will be the foremost duty of the Head of each institution/school to get the form filled up from the eligible student of their respective institutions falling under their educational jurisdiction and will process the matter further in time bound manner.

Since the H.P. Board of School Education have done away with 10+1 class Board Examination w.e.f.March 2011, the renewal of this Scholarship for n10+2 class for 2012-13will be made on the basis of 10th class H.P. Board of School Education Examination Merit list of the previous session.
