ORDER :

WHEREAS the Adidravidar Welfare Department, Pondicherry is implementing a scheme of "Award of Pre-matric Scholarship to Scheduled Caste Students studying from VI Std. to X Std. in the Government Schools and Private Schools recognised by the Government in this Union Territory";

AND WHEREAS the implementation of the Scheme has been regulated so far in accordance with Ministry of Home Affairs, New Delhi vide letter No.11014/39/82 - SCBCD-IV, dated 2.8.1983 communicated vide Government Order read above;

AND WHEREAS the matter of framing of necessary rules to implement this Scheme promptly and effectively has been under active consideration of the Government for some time past;

AND WHEREAS it is proposed to enhance the amount of Scholarship from the existing rate of Rs.15 to Rs.100 for students of Std.VI to Std.VIII and from Rs. 20 to Rs.200 for students of Std. IX and Std.X per mensem for 10 months in an academic year;

AND WHEREAS it is also proposed to enhance the annual income ceiling for parents/guardians of the students from Rs.9000/- to that prescribed for families below poverty line i.e., Rs.24,000/-.

NOW, THEREFORE, the Lieutenant Governor, Pondicherry is pleased to order that the award of Pre-matric Scholarships to Scheduled Caste students studying in Standard VI to Standard X shall be governed by rules called "The Rules for the award of Pre-matric Scholarship to the Scheduled Caste students studying from VI Standard to X Standard 2003" as appended herewith.

RULES FOR AWARD OF PRE-MATRIC SCHOLARSHIP TO SCHEDULED CASTE STUDENTS STUDYING FROM VI STANDARD TO X STANDARD.

1 **SHORT TITLE AND COMMENCEMENT:**

- (i) These rules may be called "Rules for Award of Pre-matric Scholarship to Scheduled Caste students studying from VI Standard to X Standard, 2003".
- (ii) They shall extend to the whole of the Union Territory of Pondicherry.
- (iii) These rules shall come into force from the academic year 2003-04.

2 **OBJECT OF THE SCHEME:**

The object of the scheme is to provide financial assistance to Scheduled Caste students to complete their education upto secondary level and to avoid the drop out of the Scheduled Caste students from their education.

3 **DEFINITION:**

- (i) "Director" means the Director of Adidravidar Welfare Department, Pondicherry
- (ii) "Form" means the application form appended to these rules.
- (iii) "Government" means Administrator appointed by the President of India under Article 239 of the Constitution of India.
- (iv) "Scheduled Caste" means the caste which has been so declared in relation to the Union Territory of Pondicherry under article 341 of the Constitution of India.
- (v) "School" means Government and Private Middle and Secondary Schools recognised by Government in the Union Territory of Pondicherry.
- (vi) "Students" includes both Boys and Girls studying from Standard VI to Standard X.
- (vii)

4 **ELIGIBILITY:**

- (i) Boys and Girls belonging to Scheduled Caste Community and studying from Standard VI upto Standard X are eligible to avail the Scholarship. Necessary Caste Certificate obtained from Tahsildar/Deputy Tahsildar of the concerned Taluk or Sub-Taluk shall be produced along with the application

- (ii) They shall be native of the Union Territory of Pondicherry by virtue of birth or having residence for a continuous period of not less than five years. Students will be required to produce in this regard a Nativity Certificate or a Residence Certificate as the case may be obtained from Tahsildar / Deputy Tahsildar of the concerned Taluk or Sub - Taluk.
- (iii) The Scholarship will be available only if the student is continuing his/her studies satisfactorily i.e. he/she secures promotion to the next higher class annually.
- (iv) The annual income of the parents/guardians shall not exceed the limit of income for the below poverty line prescribed by the Government from time to time.

5. AMOUNT OF SCHOLARSHIP:

The Scholarship shall be granted for 10 months in an academic year at the following rates:

VI Standard to VIII Standard - Rs.100/- (Rupees one hundred only) p.m.
IX Standard & X Standard - Rs.200/- (Rupees two hundred only) p.m.

6. PROCEDURE FOR APPLYING:

- (i) An application for scholarship shall comprise of:
 - (a) The application for scholarship in the prescribed form duly filled in and signed by the student and countersigned by the parent/guardian.
 - (b) Caste, Nationality and Income Certificates in the prescribed form (Form - I) obtained from Tahsildar / Deputy Tahsildar of Taluk or Sub-Taluk.
- (ii) The application should be submitted to the Director of Adidravidar Welfare through the Head of Institutions where the students are studying on or before 31st August every year.

7. OTHER CONDITIONS FOR THE AWARD:


The benefit of this scheme will be available only to bonafide students so long as they continue their studies satisfactorily in the recognised institution of this Union Territory.

8. **MODE OF DISBURSEMENT:**

- (i) On being satisfied that the applicant has fulfilled all the conditions, the Director shall sanction the Pre-matric Scholarship to the eligible Scheduled Caste students, after getting necessary expenditure sanction therefor from the Government.
- (ii) The amount of scholarship will be disbursed to the Students through the Schools concerned. If a student is found to have availed the scholarship by furnishing false Statement/facts, his/her scholarship shall be cancelled forthwith and the amount of Scholarship already paid till then shall be recovered at the discretion of the sanctioning authority.
- (iii) The scholarship will be paid once in a year.

9. **REMOVAL OF DOUBTS.**

If any doubt arises to the interpretation of these rules, the decision of the Government thereon shall be final.

The Lieutenant Governor, Puducherry is hereby pleased to enhance the quantum of Pre-matric scholarship to Scheduled Caste Students studying from VI to X Standard in Government schools and Government recognized private schools under the scheme of "Award of Pre-matric Scholarship to Scheduled Caste students studying from VI Std to X Std. in Government Schools and Government recognized Private Schools in the Union Territory of Puducherry" and for the said purpose hereby makes the following amendments to the rules notified in G.O. Ms. No. 17/2003-Wel (SCW.II) dated 22.9.2003 of Welfare Secretariat, Pondicherry and published in the Part II Extraordinary Gazette of Pondicherry No.29 dated 23rd September, 2003, namely:-

AMENDMENT

In the Rules for award of Pre-Matric Scholarship to Scheduled Caste Students studying from VI Standard to X Standard, 2003, for rule 5, the following shall be substituted, namely:-

*5. Amount of Scholarship:- The scholarship shall be granted for 10 months in an academic year at the following rates:-

VI Standard to VIII Standard - Rs.150/- (Rupees One hundred and fifty only) per month.

IX Standard & X Standard - Rs.250/- (Rupees Two hundred and fifty only) per month

The Notification shall take effect from 1.4.2007
