
NOTIFICATION

The Governor, Himachal Pradesh is please to institute a Post 10+2 Scholarship Scheme named as "Kalpana Chawla Chhatravriti Yojna" for the top meritorious girls students of the State in order to inspire them for higher education. The scheme will come into force w.e.f. current financial year i.e. financial year 2012-13. The guidelines for regulation/implementation of scholarship scheme are as under:

1. The above-mentioned Scholarship will be awarded each year to top 2000 meritorious girl students of all study groups i.e. Science, Arts and Commerce streams based on passing ratio in each group as per the merit list supplied by the H.P. Board of School Education Dharamshala, for post 10+2 courses, after 10+2 Examination conducted by the H.P. Board of School Education.
2. Under this Scholarship Scheme an amount of Rs. 15,000/- [Fifteen Thousand] only will be given to per student per year.
3. The Scholarship will be given strictly on 10+2 merit declared as such by the H.P. Board of School Education, Dharamshala to the students of Government/ Government Aided/ Private Schools affiliated with H.P. Board of School Education.
4. The aforesaid Scholarship will be awarded to the girl students who take admission as a regular student in any recognized post 10+2, academic, professional or technical course from any Government Aided or recognized private institution for its full term subject to satisfactory performance each year.
5. The Scholarship will be renewed and carried on till they complete degree/diploma/ Certificate course provided there is no failure, in which case the scholarship shall cease to continue.

6. In case of any dispute, the Director, [Hr. Education] will decide all the matter/issues, immediately. However, any person aggrieved with this decision of Director [Hr. Education], may file an appeal before the Secretary [Education] to the Government of H.P. within 45 days of decision.
7. All the eligible students will have to apply on the prescribed proforma along with 10+2 Certificate, next successive passing class/diploma certificate/Admission Certificates, directly to Director of Higher Education.


