NOTIFICATION

The Governor, Himachal Pradesh is pleased to institute an incentive/Award named as "Mukhiya Mantri Protsahan Yojna" for all those students of the State who are selected and take admission for a degree course in any Indian Institutes of Technology (IIT) or All India Institute of Medical Sciences (AIIMS) and for a post Graduate Diploma Course in any Indian Institute of Management (IIMs). The Scheme shall come into force w,e,f, current financial year i.e. 2013-14. The guidelines for regulation/implementation of scholarship scheme are as under:-

1. A onetime Incentive/Awards of Rs. 75000/- (Seventy Five thousand) will be given to all those students of the State who are selected and take admission for a degree course in any Indian Institutes of Technology (IIT) or All India Institute of Medical Sciences (AIIMS) and for a post Graduate Diploma Course in any Indian Institute of Management (IIMs).
2. All the eligible students will have to apply on the prescribed proforma along with Selection/Admission proof directly to Director of higher Education.
3. In case of any dispute, the Director (Hr.Education) will decided all the matter/issues, immediately. However, any person aggrieved with the decision of Director (Hr/Education), may file an appeal before the Secretary (Hr.Education) to the Government of Himachal Pradesh within 45 days of decision.
