5. PROCEDURE FOR APPLYING

- (i) An application for scholarship shall comprise of
- (a) The application for scholarship in the prescribed form duly filled signed by the student and countersigned by the parent/guardian and
- 0 Caste, Nationality and Income Certificates in the prescribed form (For - I) obtained from Tahsildar / Deputy Tahsildar of Taluk or Sub-Taluk
- through the Head before 31st August every year The application should be submitted to the Director of Adidravidar Welfare of institutions where Ste students are studying, on

MODE OF DISBURSEMENT:

- (i) On being satisfied that the applicant has fulfilled all the conditions, the Director shall sanction the Pre-matric Scholarship to the eligible Scheduled Caste students, after getting necessary expenditure sanction therefor from the Government.
- (ii) The amount of scholarship will be disbursed to the Students through the Schools concerned. If a student is found to have availed the scholarship by furnishing false Statement/facts, his/her scholarship shall be cancelled forthwith and the amount of Scholarship already paid till then shall be recovered at the discretion of the sanctioning authority.
 - (iii) The scholarship will be paid once in a year.

9. REMOVAL OF DOUBTS:

If any doubt arises to the interpretation of these rules, the decision of the Government thereon shall be final.
